- 1. Animals allowed shall be limited to common house pets (Domestic Dogs).
- 2. Aggressive breeds such as Pit bulls are strictly prohibited
- 3. Pets must be on a leash (no longer than 6 feet) when outside and must be attended by an adult.
- 4. No pet shall be permitted to roam freely outside the Unit under any circumstances.
- 5. Pets may not be tethered outside nor are tethers allowed.
- 6. The use of pet houses, crates, pens, cages, gates etc. is not permitted outside of the Unit for any purpose.
- 7. Pet owners shall insure proper, timely, and up-to-date licensing and inoculations of their pets.
- 8. Pet waste must be collected and removed immediately upon the pet depositing it. This is in conformity with applicable state and local law.
- 9. Prevent urination in the same spot, as it will kill the vegetation.
- 10. Unit Owners' accounts will be charged back for the cost of maintenance and/or repairing of any damage due to cleaning up after their pet(s).
- 11. Tenants are prohibited from owning pets.
- 12. Pets are to be properly cared for with regular feeding and fresh water.
- 13. Pets shall not be kept in a manner as to constitute a nuisance to other Unit Owners.
- 14. Permission may be revoked at any time in the sole discretion of the board.
